Under the Rules for Enforcement of Lawyer Conduct promulgated by the Supreme Court of the State of Washington, you have been directed to receive this FORMAL REPRIMAND.

During the period between July 1, 2007, and July 31, 2010, you maintained two lawyer trust accounts for which you failed to maintain complete and accurate trust account records. As a result of your failure to maintain complete and accurate records, you disbursed funds on behalf of clients or third persons that exceeded the funds of those persons on deposit, you used the funds of some clients or third persons on behalf of others, and you failed to promptly pay or deliver funds that clients or third persons were entitled to receive. Your conduct in this regard violated RPC 1.15A(e), RPC 1.15A(f), RPC 1.15A(h)(1) - 1.15A(h)(2), RPC 1.15A(h)(6) - 1.15A(h)(9), and RPC 1.15B.

1	These actions merit a Formal Reprimand. Your actions discredit you and the legal
2	profession and show a disregard for the high traditions of honor expected from a member of the
3	Association.
4	NOW, THEREFORE, YOU ARE HEREBY REPRIMANDED by the Washington State
5	Bar Association for this misconduct. This Reprimand will be made a part of your permanent
6	record with the Association, and will be considered along with other evidence regarding any
7	future grievances against you.
8	Your privilege to practice law in the State of Washington is based on the finding that
9	you are a person of good moral character, and on your commitment to abide by the rules
10	governing the conduct of members of the Association. The Association expects all your future
11	conduct as a lawyer to be consistent with that finding as to your character, and with a continuing
12	commitment on your part to the letter and spirit of those rules.
