DISCIPLINARY BOARD ORDER ADOPTING HEARING OFFICER'S DECISION

This matter came before the Disciplinary Board at its September 8, 2023 meeting, on Respondent's appeal of Hearing Officer Henry E. Stiles II's Findings of Fact, Conclusions of Law and Sanction Recommendation, recommending disbarment following a hearing.

The Board reviews the hearing officer's finding of fact for substantial evidence. The Board reviews conclusions of law and sanction recommendations de novo. Evidence not presented to the hearing officer or panel cannot be considered by the Board. ELC 11.12(b).

Having reviewed the materials submitted, and considered the applicable case law and rules;

IT IS HEREBY ORDERED THAT

- The Hearing Officer's decision is adopted¹
- Respondent's request for additional proceedings under ELC 11.11 is denied.²

Atreya, Marsh, and Brangwin voted to reverse the Sanction Recommendation. Marsh also voted to reverse the Findings of Fact and Conclusions of Law. Sanders, Hayes, Devenport, Jones, Koch, and Ildbaatar did not participate.
