Respondent will be subject to probation for a period of two 20 years commencing upon reinstatement, with periodic reviews 21 under ELC 13.8 of Respondent's trust account practices, and 22 23 ¹ The vote was 10-0. 1	must comply with the specific probation terms set forth below.
2	The remainder of paragraph 38 remains unchanged.
3	This stipulation, as conditioned, will be deemed approved if both parties
4	serve written consent to the conditional term. The written consent must
5	be served on the Clerk within 14 days of service of this order.
6	The Board will reconsider this decision if the parties file a joint motion
7	requesting reconsideration. This motion should be in writing and filed
8	with the Clerk within 14 days of service of this order. The parties may
9	ask to address the Board.
10	If either party fails to respond to this order in writing within 14 days, the
11	Board will enter a final order rejecting the stipulation.
12	The Parties' request for a protective order is granted. The
13	Revised Client Balance List and Confidential Addendum to the
14	Stipulation are confidential and shall be filed under seal pursuant to
15	ELC 3.2(e).
